MEMORANDUM OF AGREEMENT BY AND BETWEEN THE BINGHAMTON-JOHNSON CITY JOINT SEWAGE BOARD AND

UNIT #6153 BROOME COUNTY LOCAL 804 OF THE CIVIL SERVICE EMPLOYEES ASSOCIATION, INC

The Binghamton-Johnson City Joint Sewage Board, hereinafter referred to as the "Board", and Unit #6153 Broome County Local 804 of the Civil Service Employees Association, hereinafter referred to as the "CSEA" have reached the following agreement for titles listed in the Collective Bargaining Agreement for January 1, 2021 to December 31, 2025:

Article 3.1.1 Recognition shall be amended to include the title of Confidential Senior Account Clerk.

Effective February 4, 2023, the section shall be amended as follows:

3.1.1 Recognition: Pursuant to a resolution by the Joint Board, the Employer hereby recognizes the Union as the sole and exclusive representative for the purpose of collective bargaining in respect to rates of pay, wages, hours of employment, and other conditions of employment for the term of this Collective Bargaining Agreement for all the employees of the Employer in the Sewage Treatment Plant with the exception of supervisory and temporary personnel, appointed personnel not subject to any of the provisions of the Civil Service System, including the Wastewater Treatment Plant Superintendent, Assistant Wastewater Treatment Plant Superintendent, Business Manager (Wastewater Facilities), Confidential Secretary, Senior Wastewater Treatment Plant Operator (a/k/a Head Operator), Head Electrician, Head Mechanic, Plant Engineer (a/k/a Facility Engineer), Computer Systems Electrical Engineer – WWTP, and Lab Director, Safety Coordinator/Industrial Hygienist, and Confidential Senior Account Clerk.
